PARTY WALL AGREEMENT

THIS AGREEMENT is made on the date specified below BETWEEN the parties identified in Section 1 below.

WHEREAS:

This Party Wall Agreement (hereinafter referred to as the "Agreement") is entered into in accordance with the Party Wall etc. Act 1996 (as amended) to establish the terms and conditions under which works may be carried out on or near the party wall, boundary wall, or adjoining property. This Agreement aims to prevent disputes and ensure a smooth process for construction and renovation activities between the adjoining property owners (the "Parties").

DEFINITIONS:

For the purposes of this Agreement, the following terms shall have the meanings ascribed to them below:

"Party Wall" means a wall that stands on the land of two or more owners and is used to separate buildings or properties;

"Adjoining Owners" means property owners whose properties are adjacent to one another, particularly in relation to a Party Wall;

"Building Owner" means the owner of the property who intends to carry out the Notifiable Works;

"Notifiable Works" means construction or renovation activities that require notification to the Adjoining Owners under the Party Wall etc. Act 1996;

"Party Wall Surveyor" means an independent professional appointed to resolve disputes between Parties regarding the Party Wall Agreement;

"Consent" means written agreement by the Adjoining Owner to the proposed works.
