

Foreclosure rarely starts with one dramatic event. It usually begins with a missed payment, then another, then a letter that gets shoved in a drawer because opening it feels too heavy. Why speed matters more than perfect price

A traditional sale can take weeks just to prepare, then more weeks for showings, inspections, lender approval, repairs, and closing. That timeline can work if the owner has a wide cushion.
