

How an Anion Gap Assesses

The **anion gap** is a calculated value used to assist in interpret **electrolytes** and overall **acid-base status**. It is usually derived from the main numbers on a **serum chemistry panel**: **sodium**, **chloride**, and **bicarbonate**. Because it reflects the balance between measured positive and negative ions, it can provide an important **diagnostic clue** when a lab result does not match the expected pattern.
