

The drum bearing and compressor rank among the most expensive washing machine components to replace, often costing \$400 to \$800 depending on the brand. However, the real financial risk isn't the repair bill itself—it's the warranty denial exposure that follows when repair decisions conflict with manufacturer coverage terms. 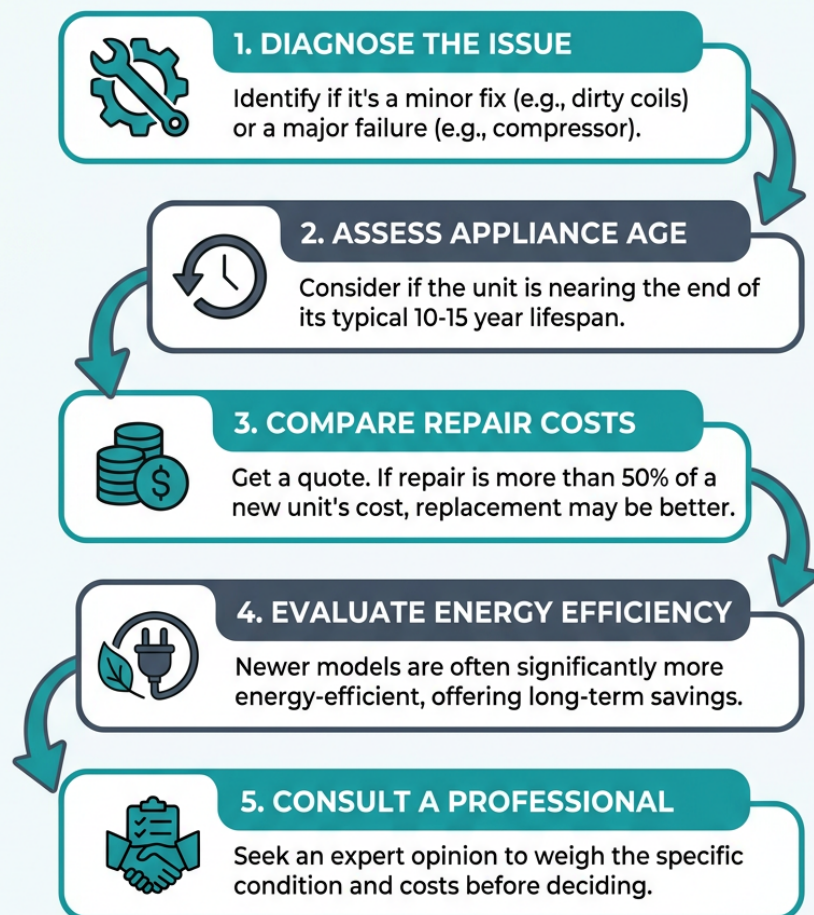

A washing machine that develops a bearing fault in year two is technically covered for the part under extended terms, but if any prior unauthorized repair is discovered during the claim investigation, the entire claim is denied and you pay the full \$500 to \$800 labor cost.
