3. Moving Restrictions for the Child

4. Notification of Proposed Move

Before a residential parent may change the child's residence, they must notify the other parent of the new address (including county and state) to the extent known.

- a. Such notice must be given at least 14 days before the move.
- b. If the non-moving parent wishes to object, they must do so within 7 days of receiving notice.
- c. Notices and objections must be given by certified mail, return receipt requested.

5. Parent Relocation

If a move from a residence by one of the parents will make the parenting time schedule unreasonable or adverse to the child's best interests, the parents must negotiate an agreement before the move can occur.
