



In Morris County, pest problems rarely start as dramatic events. They begin quietly, in a crawl space that stays damp after a storm, behind a pantry shelf where a torn bag of pet food goes unnoticed, or along a foundation gap that looked too small to matter. By the time homeowners see obvious activity, the problem has often been building for weeks or months.

Early warning signs usually include the following:

- droppings in cabinets, along baseboards, or near stored items
- faint scratching, rustling, or gnawing sounds in walls or ceilings
- grease marks, rub marks, or smudges along rodent travel routes
- hollow-sounding wood, frass, or bubbling paint near moisture-prone areas
- recurring insect sightings in the same room, even if the numbers seem small

Why Morris County homes are especially vulnerable at certain times of year

Local climate patterns shape pest behavior more than most people realize. Winter does not eliminate pest pressure, it changes it. Summer does not create every pest issue, it simply makes some of them more visible.

During late fall and winter, rodent calls tend to increase because mice and rats are seeking warmth and reliable food sources. Even a well-kept home can become attractive if exterior gaps open around utility lines, garage door corners, or aging weather seals. A mouse does not need much room to enter. Once inside, it tends to follow predictable routes close to walls, hidden storage areas, and insulated spaces.

Spring often brings an increase in ant activity, especially around kitchens, bathrooms, and foundations. Moisture from thawing ground and rain can also expose drainage problems that support carpenter ants or make subterranean termite conditions more favorable. Winged swarmers, when they appear, tend to alarm homeowners, and rightly so. They do not always mean severe structural damage, but they should never be brushed off.

Summer raises pressure from stinging insects, mosquitoes, and many outdoor nuisance pests. Nests under eaves, in shutters, inside sheds, and near deck framing can go unnoticed until they are disturbed. Ticks also remain a concern in properties bordering brush, woods, and leaf litter. In neighborhoods where yards blend into natural areas, pest management often has to consider both the structure and the surrounding landscape.
