

Losing someone in a preventable crash is not a legal problem first. It becomes one eventually, often when the bills arrive or an adjuster calls.

Georgia handles a death case differently than most people expect. Two separate claims generally exist. One belongs to the surviving family and covers what the law calls the full value of the life that was lost. The other belongs to the estate and covers the last medical expenses, the funeral, and any conscious pain before death.

Who may bring the first claim follows an order set by statute. It generally begins with a surviving spouse, then children, then parents, and then the estate. Where there is a spouse and children, Georgia also sets a minimum share for the spouse.

Deadlines apply, and some are shorter than people expect. A claim involving a city, a county or a state agency can require written notice long before a lawsuit is due. Evidence also disappears, especially when a company vehicle or a business is involved.

How much does a personal injury lawyer cost in Atlanta?

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery. Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
