

What the Anion Gap Measures

The **anion gap** is a useful secondary measure from the **electrolyte panel** that supports laboratory professionals aid **acid-base interpretation** and wider **serum chemistry** review. 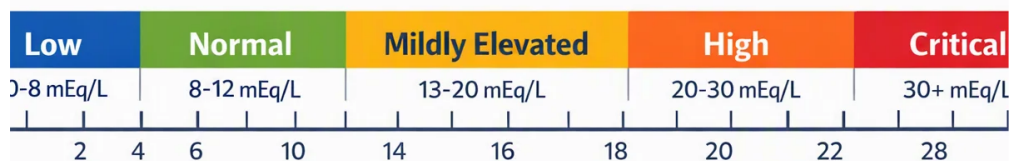
Reading Elevated and Reduced Anion Gap Results
