

If you ride and were hit in Atlanta, you are starting from behind.

There is a built in bias in motorcycle claims: that the rider was going too fast, was weaving through traffic, or took a risk a car driver would not.

Sometimes that is accurate. More often a driver looked and did not register a single headlight.

The work is physical evidence, not story, since the story is doubted before it is told. Damage patterns carry more weight than either version of events.

Severity helps and hurts. A rider has no structure around them, so identical forces cause much greater harm. The defense response is often to argue the rider accepted that risk by riding at all.
