

When a rider is hurt and someone turned across your [lawyer for big rig accident](#) path in Atlanta, you are starting from behind.

There is a built in bias in motorcycle claims: that the rider was going too fast, was weaving through traffic, or took a risk a car driver would not.

Sometimes it fits. Frequently the driver simply did not see the motorcycle and turned across it.

## **What should I do after a truck accident in Atlanta?**

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
