

When a rider is hurt and someone turned across your path in Atlanta, there is a prior you have to overcome.

There is a built in bias in motorcycle claims: that the rider was speeding, was weaving through traffic, or took a risk a [affordable personal injury lawyer](#) car driver would not.

Sometimes that is accurate. More often a driver looked and did not register a single headlight.
