

What the Anion Gap Measures

The **anion gap** is a calculated value that helps clinicians understand **electrolytes** and general **acid-base balance**. It is not directly checked on a blood test; instead, it is calculated from standard lab values, notably **sodium**, **chloride**, and **bicarbonate**. Because these numbers are part of the same chemistry panel, changes in one can affect the final result and its **clinical significance**.

At a basic level, the anion gap estimates the difference between the main positively charged and negatively charged ions in the blood. This makes it a useful **diagnostic clue** when reviewing an unexpected result on a **blood test**. 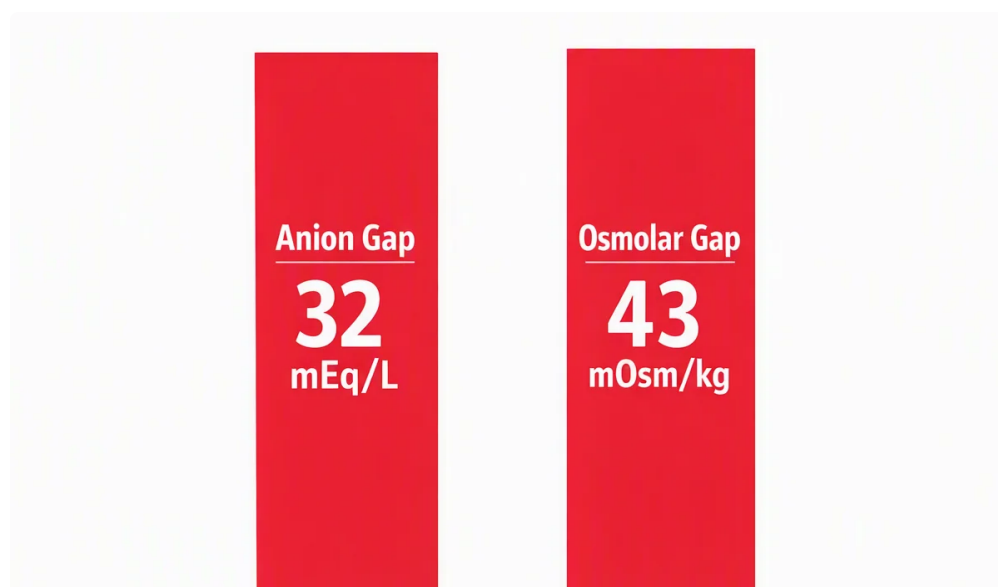
