The difference starts in the first hours. The trucking company often sends its own people to the scene before the road is even clear, while you are still in the emergency room. They start protecting the company immediately.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
