

If an electrical injury happened at work around Atlanta, several companies may share responsibility.

A site has an owner, a general contractor, the electrical sub, sometimes the utility, occasionally an equipment maker, and sometimes a labor supplier. Each carries its own coverage and its own reason to blame someone else.

If the injury happened at work, workers compensation covers medical treatment and part of your lost wages, and it bars a suit against your employer. It does not stop a claim against another company that caused the danger.

The claim against the other company is normally where the meaningful money is, since comp covers none of the human loss and only [truck accident injury lawyer](#) part of the financial one.

Establishing who controlled the hazard requires the site contracts and the safety documentation, none of which an injured worker can obtain by asking.
