

If you or your child were bitten in Georgia, the legal standard surprises most people.

Certain states impose liability regardless of the animal's history. Georgia is not one of them. Usually it comes down to whether the owner knew the animal was dangerous, or whether the dog was loose in violation of a local leash ordinance.

Establishing what the owner knew is not easy. Owners rarely volunteer that a dog [truck accident claim lawyer](#) has snapped before, and witnesses on the same street tend to stay quiet.

A leash law violation is often the clearer path, so the early questions focus on whether the animal was restrained and whether a complaint was ever filed.

Records disappear quickly here. Animal control files and witness memory both degrade, and the animal may be rehomed or euthanized before its history is ever documented.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
