

A truck wreck is not a car wreck. A loaded tractor trailer can weigh many times what your car weighs, and [atlanta personal injury attorney](#) the injuries are usually far worse.

The difference starts in the first hours. Trucking companies frequently send an investigator to the scene the same day, before you are out of the hospital. They start protecting the company immediately.

#### **How much does a personal injury lawyer cost in Atlanta?**

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery. ## **How long do I have to file an injury claim in Georgia?**

Georgia generally gives an injured person two years from the date of the injury to file a personal injury lawsuit, and a claim against a city, county or state agency can require written notice far sooner than that. ## **What should I do after a truck accident in Atlanta?**

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
