

Faq A MIAM (Arbitration Info and Assessment Meeting) is a preliminary conference with a household mediator. Do both parents have to go to a MIAM?

If you determine to head to court, you'll normally need to show you've actually participated in a MIAM prior to you use. If you participate in a MIAM however your ex-partner does not, you can still relate to go to court. You will not need to go to a MIAM in some situations, as an example if there's been residential misuse.

It's prudent to extensively check your choices and clear up with the moderator which costs are fixed and whether there are any added charges. The safety and health and wellbeing of all events is the main concern. If there has been residential abuse, your moderator will very carefully examine whether mediation is suitable and risk-free. In many cases, shuttle arbitration-- where events remain in separate areas-- might be used. In others, mediation might not be suitable and your moderator will support you in recognizing your other alternatives.
