

A truck crash is not the same as a car crash. A fully loaded truck can outweigh your car many times over, and people tend to get hurt much worse.

The difference starts in the first hours. The trucking company often sends its own people to the scene within hours, while you are still in the emergency room. They begin building the company's side of the case right away.

More than one company can be responsible. The trucking company, a maintenance contractor, a freight broker, or whoever loaded [truck accident lawyer](#) the trailer can each share it. Each of those is its own question with its own evidence.

Commercial trucks also create records an ordinary car never does: hours of service logs, engine and braking data, maintenance and inspection files, and the driver qualification file. Much of it can be overwritten or discarded on a normal schedule, so a preservation demand is typically sent right away.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
