

If you or your child were bitten around Atlanta, the rules may not be what you assume.

Certain states impose liability regardless of the animal's history. That is not the Georgia rule. Usually it comes down to whether the owner knew the animal was dangerous, or whether a leash law was being broken at the time.

Proving prior knowledge is difficult. Owners rarely volunteer that a dog has snapped before, and witnesses on the same street tend to stay quiet.

The ordinance route is frequently more provable, so the early questions focus on whether the animal was restrained and whether a complaint was ever filed.

This evidence does not last. Animal control files and witness memory both <https://zandermqlb390.yousher.com/injury-lawyers-in-atlanta-georgia> degrade, and the animal may be rehomed or euthanized before its history is ever documented.
