

If you ride and someone turned across your path in Georgia, the assumption is already working against you.

There is a built in bias in motorcycle claims: that the rider was speeding, was lane splitting or weaving, or accepted a risk nobody else would.

Sometimes it fits. Frequently the driver simply did not see the motorcycle and turned across it.

These cases get built on physical evidence rather than narrative, because narrative starts at a disadvantage. The geometry of the turn carry more weight than either version of events.

Severity helps and hurts. **lawyer for big rig accident** A rider has no structure around them, so identical forces cause much greater harm. The defense response is often to argue the rider accepted that risk by riding at all.
