

If you or your child were bitten in Georgia, Georgia works differently than people expect.

Certain states impose liability regardless of the animal's history. Georgia is not one of them. The question is normally whether the owner knew the animal was dangerous, or whether the dog was loose in violation of a local leash ordinance.

Proving prior knowledge is difficult. People do not readily admit their dog has a history, and witnesses on the [Get more info](#) same street tend to stay quiet.

A leash law violation is often the clearer path, so the early questions focus on whether the animal was restrained and whether a complaint was ever filed.

This evidence does not last. Animal control files and witness memory both degrade, and the animal may be rehomed or euthanized before its history is ever documented.
