

Cloudland, Georgia, sits in that part of northwest Georgia where the landscape still feels stitched together by ridgelines, wooded hollows, and long views that change with the season. It is not the sort of place that announces itself loudly. You notice it gradually, through the curve of a road, the coolness that settles on the mountain in the evening, and the way local people talk about distance in terms of “over the ridge” instead of miles.
