

Losing someone in a preventable crash is not a legal problem first. It becomes [best Atlanta car accident lawyer](#) one later, usually when the bills arrive or an insurer calls.

Georgia treats a death case differently than people tend to assume. Two separate claims generally exist. One belongs to the surviving family for what Georgia calls the full value of the life of the person who died. The other belongs to the estate and covers the last medical expenses, the funeral, and any conscious pain before death.

Who may bring the first claim follows an order set by statute. A surviving spouse generally comes first, then children, then parents, and then the estate. When there is a surviving spouse and children, the law also sets a floor [atlanta personal injury attorney](#) on the spouse's share.

Deadlines apply, and some are shorter than people expect. A claim against a government entity can require written notice far sooner than the filing deadline. Evidence also thins out, particularly where a commercial vehicle or a business is involved.
