

If you were hurt on a bus in Atlanta, there is a clock most people never hear about.

An ordinary Georgia injury claim generally allows two years to file. Where a government entity owns the bus, written notice may be due in months rather than years, and it has to be in the right form and go to the right place.

A late notice can close a good claim before anyone looks at the merits.

Who owns the bus drives the analysis. Injuries on a public transit bus, a school bus, a private charter and a hotel shuttle each run on different rules. Ownership sets the notice requirement, the immunity analysis and the coverage available.

There is a second deadline nobody announces. Transit and charter buses carry multiple cameras, and retention is often measured in days or weeks. Ask too late and there is nothing left to preserve.
