

When you are hurt after a fall in Georgia, there is more to it than the hazard itself. Proving the hazard existed is only the start.

Georgia law generally requires that the property owner knew about the hazard, caused it themselves, or should have found it through reasonable inspection.

That is why moving early matters. Surveillance video cycles in a matter of days at many businesses, and once it is gone there is no way to show how long the hazard sat there.

Incident reports are written by the party you will be making a claim against, which shapes what they contain. The store's own inspection records matter just as much, because a policy nobody followed is its own kind of evidence.
